

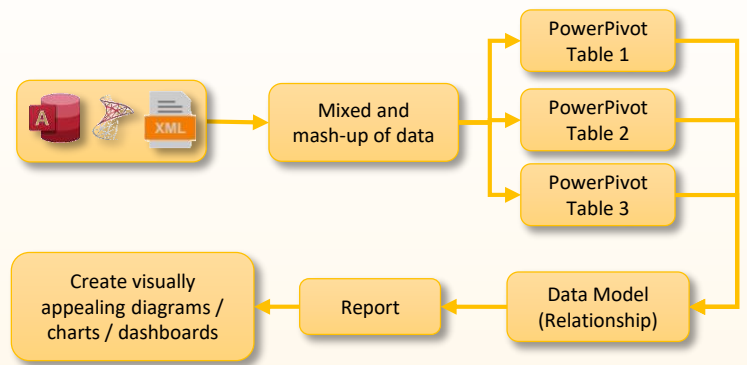


# PowerPivot: Powerful Data Analysis and Data Modelling in Microsoft Excel (2 days)
