## INTRODUCTION :

According to Section 29A (1) of the Occupational Safety and Health Act 1994, any workplace in Malaysia that employs five or more employees shall appoint one Occupational Safety and Health (OSH) Coordinator.

Section 29(4) stipulates, failure to appoint an OSH Coordinator will result in penalties not exceeding RM50,000 or imprisonment not exceeding six months.

Engku Nasir Bin Syed Mohamad holds a Master's degree in Occupational Safety and Health from Universiti Utara Malaysia, which he obtained in 2009. He also obtained a Bachelor of Science (Hons) in Science from Universiti Kebangsaan Malaysia in 1983. He works as a freelancer OSH Trainer, certified by the HRDC. Engku Nasir has conducted OSH Coordinator training at various training providers, including Malaysian Plastic Manufacturer Association, Petaling Jaya, Mahagami Consultancy and Advisory Sdn Bhd, Sibul, SHE Monitorings (M) Sdn Bhd, Melaka, Pertubuhan Ikatan Komuniti Selamat (IKATAN), Kuala Lumpur and Angkasa Research and Certification Sdn Bhd, Petaling Jaya. Moreover, he serves as an Auditor and Lead Promotion to the Malaysia Society of Occupational Safety and Health (MSOSH) and Health OSH Audit Program. In 2010, Engku Nasir engaged in part-time lecturing in OSH with the National Institute of Occupational Safety and Health (NIOSH) and Open University for their Diploma programs.

### **• Capt (R) Wan Hock Leong, P.J.K., P.J.M., P.P.A**

Captain Wan's journey to becoming a champion for construction safety began in 1965, when he honed his leadership skills with a Diploma in Military Studies at the Federation Military College. This foundation of discipline and meticulousness would serve him well in the years to come. His thirst for knowledge and technical expertise led him to Waiouru Military Base in New Zealand, where he mastered the intricacies of Basic Radio Engineering in 1966. This seemingly unrelated skill would later become an asset, as clear communication is paramount in ensuring safety protocols are understood and followed on construction sites.

Back in Malaysia, Captain Wan's dedication to safety transcended national borders. In 1986, he joined an esteemed panel of experts assembled by the International Labour Organization (ILO) in Bangkok. Here, his expertise played a crucial role in developing a comprehensive Construction Safety Training Module. This module would empower construction workers worldwide with the knowledge and skills to navigate their jobs safely. Captain Wan's influence continued to grow. In 1991, he was invited to Geneva by the ILO to contribute to the creation of a Code of Practice for the Construction Industry. This code would become a cornerstone for establishing safety standards and best practices across the globe.

His unwavering commitment to worker safety wasn't limited to international forums. Recognizing the need for local action, Captain Wan actively participated in a 1993 seminar on the Prevention of Major Industrial Accidents in Jakarta, representing Malaysian Employers. But what truly sets Captain Wan apart is his unwavering dedication to education and knowledge sharing. He tirelessly pursued qualifications, becoming a Competent Person for Scaffold Erection, a Registered Safety and Health Officer, and a Registered Trainer for a multitude of safety programs offered by esteemed organizations like DOSH, CIDB, MII, NIOSH, VETA, JKM, and HRDC.

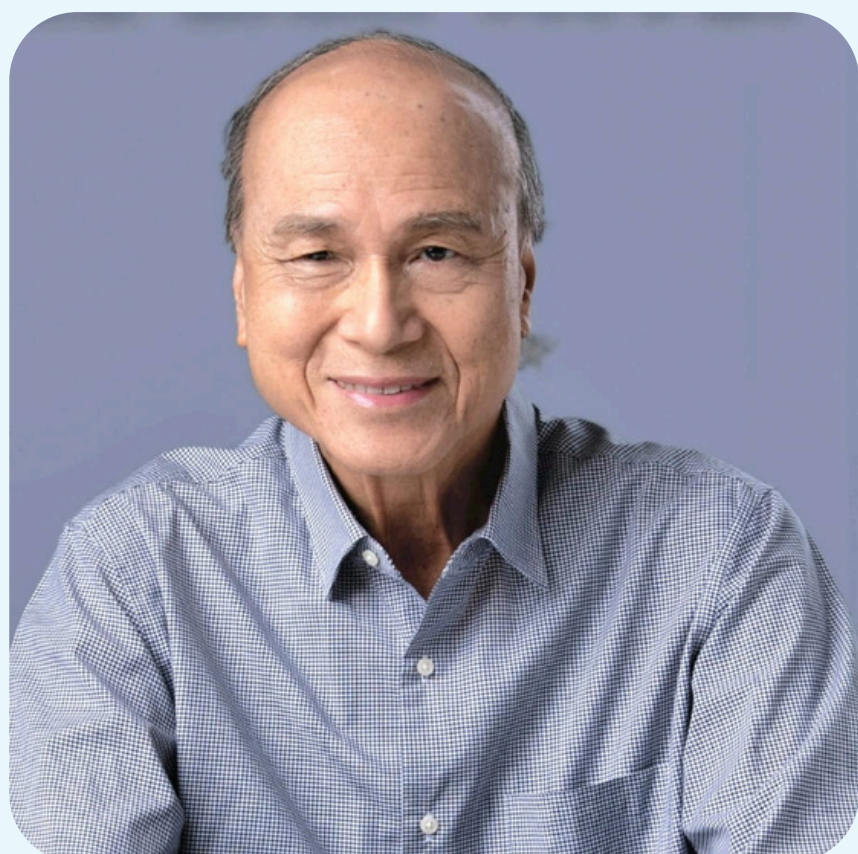
